Abstract

Introduction to The Problem: The COVID-19 pandemic has had a major impact on society. not only physical changes, but psychological changes in the form of character become a serious problem. **Purpose:** The presence of this research is to find out the response to the pandemic disaster, whether it will then make humans, especially students, strengthen mutual cooperation, help others as a social human being in the Al-Quran called An-Nass. Through communities, student organizations, or community groups in participating in social humanity during a pandemic disaster. **Design/methods/approach:** This research is a quantitative research, where the data collected is the result of data obtained through a questionnaire (questionnaire). Sampling used a cluster sampling technique with 70 PAI student respondents, while the research location was at UIN Sunan Kalijaga Yogyakarta. Data collection techniques in this study used a questionnaire through the Google form. Data analysis techniques used simple linear regression analysis with the help of SPSS version 25 software. **Findings:** The results showed that in the presence of a pandemic disaster, the average student with social human character (An-Nass) showed a significant negative effect of 16.6%, while 84.4% of PAI students improved their social character by helping each other, one each other not only during the pandemic. **Research implications/limitations:** The results of this research can be a simple guide for future researchers regarding human character, especially related to the impact of the Covid pandemic. **Originality/value:** This study found important findings that human character when facing problems together, the attitude of helping each other and helping each other is a character that appears a lot.

Then if population more of 100 then according to suharsimi arikunto, sample taken between 15% -20% or 25% of the total population whole. Results

After inputting the data from the questionnaire results in Microsoft Excel, the researcher performed SPSS calculations using a simple linear regression test. But beforehand it is necessary to know the validity and reliability tests, then the normality test so that the data can be normally distributed between the independent variable (X) and the dependent variable (Y). The validity test is used as a calculation of the validity or suitability of the questionnaire used by researchers to

obtain data from respondents or research samples. Test the validity of the product moment Pearson correlation connecting each item or item score with the item score obtained from the sample.

Comparing the calculated R values with R Tables . If the value of $r_{count} > r_{table}$, then the item of the questionnaire is valid. If the value of $r_{count} < r_{table}$, then the item in the questionnaire is invalid. Comparing the Sig. (2-tailed) with a probability of

0.05 . If the value of Sig. (2-tailed) < 0.05 and the Pearson correlation is positive, then the item is valid. If the value of Sig. So that then , the direction influence positive based on other factors 84.4% influence in behavior and characteristics man as An-Nass in self PAI students at UIN Sunan Kalidjaga namely : (1). Pandemic support attitude social; (2). Pandemic increase soul humanity; (3). Or pandemic can make muhasabah self as man social, for each other help in accordance ability, anyone with fundraising agent social change, or just help leaflet application hopeful donation can Lots help for people in particular economy medium down.

Conclusion

Based on results discussion to table data analysis table R, Anova, and Coffeciens about impact of the pandemic on character man as An-Nass, that is data analysis and discussion in chapter before. concluded exists emergence of pandemics and tragedies disaster that made between man difficult do activity as it should human An-Nass, namely 16.6%.

It shows exists influence with category Enough between pandemics and character man as An-Nass indicated with price $R=0.153$. Then magnitude influence positive from exists pandemic disaster ($R^2=0.407$ with 0.166 $p=0.000 < 0.05$, and its direction negative meaning _ assumed is 16.6% influence from pandemic, while 84.4% originated from direction the positive exists factor other. Hence, awareness character man as An-Nass to PAI students at UIN Sunan Kalijaga Yogyakarta does not depends exists pandemic, however every exists disasters and people in need help wherever and whenever.
